Objectives and implementation of the project

The project's objective was to increase the competitiveness of the cashew value chain in selected African countries. The project facilitated both the training of cashew farmers and research into and the distribution of improved planting material. The aim of both activities was to increase the quality and quantity of farmers' yields. The project also provided technical advice and training to cashew processing companies and their staff, to government institutions and sector associations. Those activities aimed to increase processors' competitiveness and to help governments create an enabling regulatory environment for the cashew value chain.


Key findings

Although the project needs to improve the quality of the Theory of Change, the indicators and the monitoring data, the evaluation team concludes that it performed well against DAC criteria.

- All target groups see the content of the training and support they received as highly relevant to their needs and requirements.
- The results hypotheses of the project were largely confirmed.
- The project has achieved positive developmental results (impact) in terms of the creation of jobs and the generation of income in cashew production and processing. It has also contributed to a reduction in the carbon footprint of cashew nuts through increased incountry processing.

Conclusions

- With advice and technical support from the project, local governments were able to establish cashew departments and develop cashew sector strategies.
- Stakeholders and Farmer Based Organisations are convinced that the training of 700,000 farmers in Good Agricultural Practices has contributed to an increase in yield and income.
- The distribution of improved planting material shows great potential for further upscaling in the future.
- While the national volume of processed cashew has increased tremendously, many processors still struggle with volatile price developments and with access to finance and technology.
